## D. STUDENT REPRESENTATIVE REPORT

**Shania Stanton** reviewed the Homecoming activities, noting the sophomores won the parade with a phenomenal float and amazing performance. Unfortunately MHS lost the football game to Glastonbury with a score of 27-37.

Turkey Bowl will be on November 10th and admission is either \$2 or 2 cans of food to be donated to MACC Charities.

Heartchase was rescheduled to tomorrow, 10/25, on the practice field.

Thursday, 10/27, is Financial Aid night in the MHS cafe from 6:30 to 8:30.

**Nabila Hoor Un Ein** reminded everyone that the Community Halloween Party is being hosted by APB and FBLA this Saturday, 10/29 from 11 to 1 for elementary age children. There will be games, snacks, and activities.

Shania noted 11/2 is class ring night where parents can view options in the lobby. SAT day is November 5th.

Nabila noted the holiday craft fair to benefit the class of 2018 will be held November 12 from 10 to 3 in the MHS cafe.

Last, Shania mentioned the VEX competition at MHS at 9am.

Mr. Pattacini asked the girls for a written list of their events.

#### **E. PUBLIC COMMENTS**

Mr. Tom Stringfellow, 183 Hillstown Road, noted this is the end of Hispanic Heritage Month and he suggested an article on stereotypes of Latin Americans along with an article in the *NY Times* on how children can learn and unlearn prejudice. On the 13th there is a documentary he suggests on the imprisonment of persons of color. Mr. Stringfellow recommended an article on white power in Appalachia. He noted it is the 75th anniversary of Pearl Harbor. Last, Mr. Stringfellow hopes people understand who they are voting for.

#### F. SUPERINTENDENT'S REPORT - PART I

#### F.1. Fall Data Report

**Mr. Geary** reviewed the district data dashboard, which is looked at three times a year. This information is available on the website.

**Ms. Jacobsen** was confused about the dip in grade 3 from 15/16 to 16/17. Mr. Geary explained these are different students.

**Mr. Pattacini** sees the trend shows we are making improvements across the board, though there are gaps in individual schools and various groups.

**Mr. Geary** noted that leadership gets this report three times a year. Lit Life is being utilized two days a month to work out strategies. We also have literacy coaches, reading consultants and Lit Night's to engage kids with books.

**Mr. Pattacini** feels we are identifying what each child needs to get to mastery. He noted that the kindergarten ESI improved except for at Robertson and he wondered if that population is underserved. Mr. Geary noted that the majority of Head Start students attend Verplanck and Washington and very few attend Robertson, so it may be that less students there had a preschool experience.

Regarding suspensions, Mr. Geary noted that we have done a good job knocking down the number of suspensions, but not as good a job in monitoring who and why. Anti-defamation league meetings are being held. We are utilizing a social and emotional learning curriculum across the district. Previously schools used two different systems to log discipline and now everyone will be using Eschool to log all discipline in the same place so it is easier to understand.

**Ms. Jacobsen** noted our math fluency seems better than reading. She wondered if special education students are tested at grade level or ability level. Mr. Geary noted most are tested on grade level, though some modifications are made.

**Mr. Pattacini** was encouraged by the focus on understanding and acting on this data and that we can see this data as a community.

#### F.2. SAAM Update

**Mr. Geary** introduced Dr. Radikas and her staff. Dr. Radikas presented a powerpoint on the summer program, which is available online. The data showed that students either maintained or increased their achievement level over the summer, avoiding the summer slide.

**Ms. Hagenow** wondered why some students increased their level during SAAM and then went back to their previous level in the fall. Dr. Radikas noted that if students are not reading that impacts them, however she pointed out students did not exhibit the summer slide usually evident and maintained their presummer levels. Ms. Hagenow wondered how many students were served in previous summers. Dr. Radikas stated that about 375 were in previous SAAM classes, however this summer we served one fewer grade.

**Ms. Jacobsen** was amazed with the results and loves the progress. She wondered if the 42 disenrolled students scores were included. Dr. Radikas stated they are not as some students disenrolled right away and some part-way into the program and there were too many variables to include that data. Ms. Jacobsen wondered if these SAAM students will accelerate levels during the school year quicker. Dr. Radikas noted they have kept copious notes on students and have visited schools as well.

Ms. Jacobsen wondered how many parents filled out the survey. Dr. Radikas noted about 65 parents did.

**Mr. Scappaticci** asked how students are recruited. Dr. Radikas noted the Fountas & Pinnell testing is done three times a year. Students who are below grade level for the winter assessment data are invited to participate in SAAM. Mr. Scappaticci was impressed that these at-risk students were able to maintain their level over the summer. He thanked the staff and Norma from Mary Cheney Library for her work with the program.

**Mr. Caldwell** thanked Dr. Radikas for her hard work and he is excited about the progress. He wondered if we have data to compare SAAM to non-SAAM student progress. Dr. Radikas does not have that data and points out that we do not know what non-SAAM students do over the summer. We would like to see how SAAM students due throughout the year.

**Mr. Pattacini** notes SAAM is a significant investment and he is encouraged by the impact it is having on student achievement. He is also excited about the partnerships within the community.

**Dr. Radikas** introduced the various staff from MELC, the library, and Central Office that participate in SAAM. She singled out Heather Elsinger, Improvement Support Specialist, for her hard work in organizing the program over the past several years and presented her with a small gift as a token of appreciation.
